UPON hearing the counsel the Court made the following

O R D E R

Diary No. 14555 of 2020

It is pointed out that respondent No. 2 - Mohan Dass has passed away. The counsel is permitted to file a memo of the deceased with details of legal heirs with copy to the other side within a week.

Civil Appeal No. 5679 of 2015

Application for substitution of legal heirs of respondent No. 2 (Veena Chhabra) has been filed together with applications for condonation of delay and setting aside abatement. Notice be issued on the said applications.

Mr. Chander Shekhar Ashri, learned AOR accepts notice for the proposed legal heirs. Hence, formal notice need not be issued.

It further appears that proposed legal heir - Rishi Chhabra has also passed away. Application for substitution of legal heirs of Rishi Chhabra has been filed together with applications for condonation of delay and setting aside abatement. Notice be issued on the said applications.

Civil Appeal No. 5684 of 2015

It is pointed out that respondent No. 48 has passed away. Application for substitution of legal heirs is filed along with applications for condonation of delay and setting aside abatement but the same are lying in defect. After the defect is cured, notice, returnable in three weeks, be issued.

Civil Appeal No. 5707 of 2015

The office report indicates that some of the respondent(s) remained unserved. The appellant is permitted to serve Dasti notice on the unserved respondent(s). As prayed, permission is also granted to take steps for substitution of the legal heirs of the deceased respondent No. 2 - Jagdish Singh.

SLP (Civil) No. 10065 of 2020

The office should give an updated/latest report on the status of service on the respondent(s).

After substitution of the deceased legal heirs and completion of service of notice on the unserved respondent(s) in the concerned matters, the matters be posted for hearing. In three weeks time, two separate convenience volume be filed i.e., one by the land losers seeking allotment of land and the other by the Amritsar Improvement Trust.
