While disposing of the matter, following observations were

made by this Court:

"Learned counsel also submitted that in terms of the order passed by the District Forum, Chandigarh, a sum of Rs.4,77,350/-was deposited with the District Forum, Chandigarh and that the petitioner would deposit the remainder sum with the District Forum within six weeks along with interest as awarded.

Upon deposit of the remainder sum, the respondent shall deliver the concerned machine to the petitioner and only thereafter the respondent shall be permitted to withdraw the sum so deposited."

Mr. Subhro Sanyal, learned counsel submits that the amount deposited by the petitioner has already withdrawn and therefore, the latter part of the aforesaid observations may be clarified.

If the decretal sum awarded by the Fora below has been withdrawn by the complainant; it goes without saying that the original complainant must return the machine.

We therefore, direct the complainant to return the machine within fifteen days from today.

This Miscellaneous application is disposed of.
