Writ Petition (C) No. 769 of 2020:

Having heard learned Counsel on both sides and having regard to the fact that the Writ Petition was filed on 14.07.2020 when counselling has not started, (it is stated to have started one month later i.e. on 14.08.2020), we set aside the order of rejection of affiliation dated 09.06.2020 and direct the authority concerned to grant affiliation for the current session, if all other parameters, short of the application being delayed are in order. This should be done within a period of five days from today.

Writ Petition stands allowed in the aforesaid terms.

Writ Petition (C) No. 718 of 2020:

Having heard learned Counsel on both sides and having regard to the fact that the Writ Petition was filed on 15.07.2020 when counselling has not started, (it is stated to have started one month later i.e. on 15.08.2019), we set aside the order of

rejection of affiliation dated 03.07.2020 and direct the authority concerned to grant affiliation for the current session, if all other parameters, short of the application being delayed are in order. This should be done within a period of five days from today.

Writ Petition stands allowed in the aforesaid terms.

Writ Petition (C) No. 803 of 2020:

The impugned letter dated 20.07.2020 rejecting the affiliation is set aside. The authority concerned is directed to grant affiliation within a period of five days from today as it is common ground that the only reason for rejecting the application for affiliation is that the requisite fee was not sent on the date of the application itself but sent a week later.
