Heard Mr. Parnam Prabhakar, learned counsel appearing for the petitioner. Also heard Mr. P. R. Kovilan, learned counsel appearing for the respondent.

The respondent has not filed counter affidavit in this transfer petition.

Considering the pleadings in the transfer petition and submission of the learned counsel, we deem it appropriate to order for transfer of H.M.O.P. No. 47 of 2019 titled as *K. Vinay @ Karani Vinay v. K. Sri Harsha* before the Court of Sub-Judge at Ponneri, Tamil Nadu to the Senior Civil Judge Court/Competent Court, Vijayawada, Andhra Pradesh.
