O R D E R

Delay condoned.

These special leave petitions have been filed against the interim order dated 01.05.2019 passed by the High Court of Punjab & Haryana at Chandigarh in Regular First Appeals filed by the petitioners questioning the order of the Reference Court. By interim order, the High Court has directed the petitioners to deposit a sum of Rs.32 lakh per acre within a period of 3 months.

In the facts of present case, we are not inclined to issue any notice to the respondents. We, however, order that the amount, directed to be deposited under the order of the High Court, shall be half of the enhanced compensation as enhanced by the Reference Court.

Liberty is reserved to the respondents to file an application, if they feel aggrieved by this order.

We make it clear that the order passed in the interim stage by the High Court shall have no bearing when the RFAs are finally decided by the High Court.

With these observations, the special leave petitions are disposed of alongwith the pending applications.
