O R D E R

Despite second call, none has entered appearance on behalf of the respondent. The respondent is proceeded *ex parte*.

Having given due consideration to the contentions raised by the petitioner and the averments made in the transfer petition, and in the interest of justice, the transfer petition is allowed.

Accordingly, Matrimonial (Divorce) Petition No. 1487 of 2019 under Section 307 (3) of the Mohammedan law titled "*Saif Alam vs. Sania Parveen*", pending before Principal Judge, Family Court, Patna, Bihar is transferred to the Court of the Presiding Judge, Family Courts, Dhanbad, Jharkhand, who may hear the case himself or assign it to a court of competent jurisdiction.

The records of the case would be transferred immediately.
