This transfer petition has been filed by the petitioner (wife) for transfer of the HMA No.3109 of 2018 from the Court at South West District, Dwarka Court, New Delhi to the Court of Principal Judge, Bhagalpur, Bihar.

Heard Mr. Amitabh Krishn, learned counsel for the petitioner and Mr. Pramod Dayal, learned counsel for the respondent (husband).

The petitioner is staying in her parental home at Bhagalpur, Bihar. Besides, a complaint case filed by her is pending before the Bhagalpur Police.

Learned counsel for the respondent submits that since the parties were married only a couple of years earlier, they be given a chance for Mediation before the transferee Court proceeds to consider the matter on merits.

Having considered the rival submissions and bearing in mind the circumstances in the matter, the HMA No.3109 of 2018 pending

before the family Court, South West District, Dwarka Court is transferred to the Competent Court at Bhagalpur, Bihar.

Before proceeding to consider the matter on merits, the transferee court should facilitate Mediation between the parties for amicable settlement of the dispute. It is ordered accordingly.

With the above order, the Transfer Petition is, accordingly, allowed.
