O R D E R

When the matter came up for hearing today, learned counsel appearing for the petitioner voluntarily submits that his client is willing to deposit a sum of Rs.15,00,000/- (Rupees Fifteen Lakhs only) to settle the dispute.

In view of the above, learned counsel for the petitioner is directed to deposit the said amount within a period of one week from today before the Registry of this Court.

Subject to deposit of the said amount by the petitioner within the stipulated period as aforesaid, the Registry is directed to issue notice in the matter.

The Registry is also directed to invest the said amount in a short-term interest-earning Fixed Deposit Receipt in any Nationalized Bank with auto-renewal facility

In the meantime, interim protection from arrest is granted to the petitioner.

The petitioner is directed to cooperate in the investigation at all stages. Additionally, the interim protection is also subject to the compliance of other conditions, as enumerated in Section 438 (2) of the Code of Criminal Procedure, 1973.
