O R D E R

SLP(CrI.)No.3441/2020

The Court is convened through Video Conferencing.

Heard learned counsel for the parties and carefully perused the record.

Taking into consideration the fact that the petitioner is already in custody for the last 3 years and 7 months as also the statement made by the learned counsel for the respondent-State that the investigation is over and the chargesheet has been filed and there is no possibility of completing the trial in near future, we are inclined to grant bail to the petitioner herein.

The petitioner is accordingly directed to be enlarged on bail on such terms and conditions to be imposed by the trial court.

The special leave petition stands disposed of accordingly.

As a sequel to the above, pending interlocutory applications also stand disposed of.

The petitioner is directed not to interfere in the trial process or try to influence the witnesses.
