Having heard the learned counsel for the parties, the averments made in the transfer petition, and in the interest of justice, we are inclined to allow the transfer petition.

Accordingly, the transfer petition is allowed and H.M.P. No. 26/2018 titled '*Raju Bhai Bhagwan Singh Versus Shweta Raju Singh*' pending before the Principal Civil Judge at Kalol, Baroda, Gujarat is directed to be transferred to the Presiding Officer, Family Court, Agra, Uttar Pradesh, who may hear the case himself or assign it to a court of competent jurisdiction.

Records of the case would be immediately transferred to the transferee court.

The parties are directed to appear, either in person or through an advocate, before the transferee court on 19<sup>th</sup> October, 2022. However, in case there is non-appearance, court notice would be issued to the defaulting party.

The parties may explore the possibility of settlement through mediation. The transferee court would obtain the desire and wishes of the parties and proceed accordingly in this regard.
