These appeals have been filed against the order dated 09.08.2019 and 09.01.2019 by the High Court, rejecting the bail applications in FIR No.232/2018 for offence under Section 306 IPC.

The learned counsel for the appellant submits that High Court without considering the nature of allegations, which were levelled against the appellant, has rejected the bail applications. Learned counsel for the appellant submits that there were no sufficient allegations against the appellant which could have been reason for rejecting the bail applications.

We have heard learned counsel for the State as well as learned counsel for the complainant. Learned counsel for the complainant has referred to suicide notes dated 21.10.2018 and 22.10.2018.

We have looked into the materials on record and heard the counsel for the parties. In the facts of the present case, we are of the view that appellant has made out sufficient grounds for grant of bail. The High Court committed error in rejecting the bail applications. In view of the aforesaid, orders of the High Court are set aside. Let the appellant be released on bail subject to terms and conditions as may be fixed by the Trial Court.

We make it clear that the observations, made by us, are only for considering the bail application of the appellant and shall have no bearing on the merits of the case.

The appeals are allowed accordingly.
