O R D E R**

MA Nos 1945-1946/2021 in SLP (C) Nos 8398-8399/2005

- 1 The Office Report indicates that service could not be completed because the applicant did not file spare copies.
- 2 The applicant shall take necessary steps to file spare copies within one week.

- 3 On the request of Mr Harin P Raval, learned senior counsel appearing on behalf of the applicant, permission is granted to implead the Union of India through the Ministry of Housing and Urban Affairs and L&DO, as well as the New Delhi Municipal Council (NDMC) as parties.
- 4 Issue notice only to the newly added parties (UOI and NDMC), returnable on 18 February 2022.
- 5 Liberty to serve the Central Agency and the Standing Counsel for the NDMC.
- 6 List the Miscellaneous Applications on 18 February 2022.

MA Nos 1741-1742/2020 in SLP(C) Nos 8398-8399/2005

- 1 The affidavit which has been filed on behalf of the Delhi Development Authority (DDA) indicates that certain records are presently untraceable and are in the process of being reconstructed.
- 2 Mr Vishnu B Saharya, learned counsel appearing on behalf of the DDA submits that the DDA will have to execute the conveyance in favour of the Official Liquidator who represents the interest of Super Bazar.
- 3 Mr Harin P Raval, learned senior counsel has stated that immediately upon receipt of a communication from DDA, such records as were available with the Official Liquidator have been transmitted.
- 4 In view of the request which has been made on behalf of the DDA by its learned counsel that the entire process will be completed within a period of eight weeks, we grant time to the DDA to do so.
- 5 List the Miscellaneous Applications on 16 March 2022 so that the Court can be apprised of the further developments which have taken place in the meantime.

- 6 The Official Liquidator and the DDA shall extend necessary cooperation in order to ensure that the statement which has been made in regard to the execution of the conveyance deed can be fulfilled.

- 1 It is common ground between Mr Harin P Raval, learned senior counsel and Mr Mohit Paul, learned counsel for the applicants that these interlocutory applications have been rendered infructuous in view of the order passed by this Court on 9 September 2020.
