O R D E R

Mr. S. Nagamuthu, learned senior counsel, has produced a Statement of Kumbabishega Ninaivarangu Shops-36 during the course of hearing before us. Column 10 of the said Statement indicates the balance due as on 30.06.2023 after deducting 8 months' Corona period rent, which as per him is rent due.

To show their bonafides, the petitioners wish to deposit the same, however, they are directed to deposit 50% of the amount due upto 31.08.2023 within two weeks from today and balance 50% shall be deposited within two weeks thereafter, without prejudice to the rights of the parties to the correctness of the Statement.
