We find that, it will not be appropriate to decide the connected cases till the review petitions are decided.

Shri C.U. Singh, learned senior counsel submits that, in view of the large number of cases being affected, it is necessary that the said review petitions should be decided immediately.

The parties would be at liberty to make an application to the Hon'ble Chief Justice of India for constitution of appropriate Bench and expeditious disposal of the review petitions.

Needless to state that the orders passed earlier shall continue to operate, unless they are specifically modified by the Court.
