UPON hearing the counsel through Video Conference, the Court made the following

O R D E R

SLP(C) No. 1623/2021

Four weeks time is given to respondent No.1 to file the counter affidavit.

Service of notice is complete on respondent No. 2 but no one has entered appearance on his behalf.

As per postal tracking report notice issued to respondent No. 3 has been received back with postal remarks "Door locked". Hence, learned counsel for the petitioner shall within a period of two weeks file the fresh particulars of the said respondent and he shall also take fresh steps for the service of notice to him within the same period. Dasti in addition is permitted to be served.
