Heard Mr.Sharanagouda Patil, learned counsel for the appellant and Mr.Abhishek Kumar, learned counsel for respondent No.2-Insurer.

In the course of hearing, a suggestion was given to the learned counsel for the appellant that if the amount of compensation is enhanced by another Rs.3,50,000/- (Rupees three lakhs fifty thousand) whether the claim be satisfied. Learned counsel for the appellant submitted that the appellant would be satisfied with the said amount. Learned counsel for respondent No.2 left it to the discretion of the Court.

Having heard learned counsel for the parties and having perused the materials on record, we think it appropriate to enhance the compensation amount by another sum of Rs.3,50,000/- (Rupees three lakhs fifty thousand). Respondent No.2 is accordingly directed to deposit Rs.3,50,000/- (Rupees three lakhs fifty thousand) before the Tribunal within twelve weeks hence, failing

which the enhanced amount shall carry interest at the rate of 9% per annum from the date of presentation of the application before the Tribunal.

The appeal is allowed to the extent indicated above. There shall be no order as to costs.
