Heard learned counsel for the parties at length and perused the pleadings of the transfer petition and the response so filed along with the documents.

On perusal thereto, it reveals that the father of the petitioner was residing in Delhi and died while the mother of the petitioner is still residing in Delhi along with her one son. Another brother of the petitioner is staying at Aara, District Bhojpur, Bihar and is in legal profession. The fact has also come on record that the petitioner left two children at a place where the respondent was serving and those children are with the respondent.

Looking into the facts and circumstances of the case, we do not find it a fit case where the petition being Matrimonial Suit No. 472 of 2017 be ordered to be transferred from the Principal Judge, Family Court at Allahabad, Uttar Pradesh to the Family Court, Aara, Bhojpur, Bihar.

The transfer petition is, accordingly, dismissed.
