O R D E R

In the course of the hearing, it was brought to our notice that the order dated 27.07.2011, passed by the Debts Recovery

Tribunal<sup>1</sup> at Coimbatore, was challenged after six years before the Debts Recovery Appellant Tribunal<sup>2</sup>, which passed an order on 03.10.2018.

The said challenge should not have been entertained by DRAT after such a long delay, especially when the sale certificates were issued in 2008 and the sale deeds registered in 2013.

It is also apparent that the petitioners have repeatedly moved the court from 2006 onwards.

Recording the aforesaid, we do not find any good ground and reason to interfere with the impugned judgment, and hence, the special leave petition is dismissed.
