O R D E R

1. In Case No.W.A.79 of 2016 (Smt. Sukla Deb (Roy) Vs. Shri Mrinal Kanti Datta & 10 others), rival parties have expressed their willingness for transferring the matter to the Gauhati High Court, and to be disposed of by the said Court.

2. In view of the above, Case No.W.A.79 of 2016 (Smt. Sukla Deb (Roy) Vs. Shri Mrinal Kanti Datta & 10 others), is directed to be transferred to the High Court of Gauhati, in exercise of the jurisdiction vested in this Court under Article 139-A of the Constitution of India.

3. Insofar as the rest of the matters are concerned, there is no consensus between the parties for the transfer of the cases to any other court. Insofar as the remaining matters are concerned, it is submitted, that the State/State agency in all these cases, is willing for the transfer. However, no private party is willing for any such transfer. In the above view of the matter, it is not

possible for us to transfer any of the remaining cases to any other court. Be that as it may, if and when any of the private parties approaches the Registrar General of the High Court, and expresses willingness for transfer to some other High court, we direct the Registrar General of the High Court, to move an application before this Court, for such transfer.

4. The transfer petition is disposed of in the above terms.
