ORDER

1. Delay condoned.
2. We have heard the learned counsel for the appellant.
3. On due consideration we do not find any cogent ground to formally admit this appeal to regular hearing. Contempt, rather repeated acts thereof, is *ex facie* apparent. We, therefore, affirm the order of the High Court holding the appellant guilty of commission of contempt and sentencing him to simple imprisonment for two months and fine of Rs.2,000/- and in default of payment of fine to undergo simple imprisonment for further period of fifteen days. However, we direct

that the cash security of Rs.2,00,000/- (Rupees two lakh) which has been forfeited by the impugned order (paragraph 18) be returned to the appellant.

4. With the aforesaid modification of the order of the High Court dated 27th and 28th February, 2017 the present appeal is dismissed by refusing admission.
