In view of all these facts and circumstance of the case, not wanting to comment anything on the merit at this stage, we enlarge the appellant on bail who has been in custody for about a year subject to the terms and conditions to the satisfaction of the trial Court.

The trial Court shall include a condition of directing the appellant and his family members not to approach or access the victim.

The appeal stands disposed of.
