Leave granted.

The only question for consideration is whether there is an option available to the post-graduate teachers for promotion in the channel of head-masters. Though the High Court has recorded a finding that no such option is available, Mr. R. Venkataramani, learned senior counsel for the Union Territory of Puducherry, submits that an option is available in the letter of promotion and thus a post-graduate is also eligible for promotion to the post of

head-master at his option. If it is factually so, it is open to the Union Territory of Puducherry to move the High Court by way of a review. The High Court may consider this aspect, if such an application is made by the appellants.

The appeal is accordingly disposed of.
