Having heard learned counsel appearing for the parties and upon perusal of the instant application, we are of the view that the college which allowed the applicants to appear in the first year D.El.Ed. examination conducted by Respondent No.1-Board, should declare their result provisionally to enable them to apply for admission to the 2nd year course.

We order accordingly.
