As both the appellants and contesting respondents [Respondent Nos. 4 to 14 in C.A. arising out of SLP(C) 18698/2014 and 4 to 25 in C.A. arising out of SLP(C) Nos.21162-21163/2014] are apparently eligible for allotment of surplus land, being the landless agricultural labourers, we direct that both the groups (appellants herein and the contesting respondents) be considered by the concerned authority according to the Government Policy and in accordance with law. Consequential

necessary orders be passed within the period of six weeks.

5. The order of the High Court is set aside and the appeals are disposed of.
