UPON hearing the counsel the Court made the following
O R D E R

As the impugned order passed by the High Court is an interlocutory one, pending Appeal, we see no reason to interfere with the same in exercise of powers under Article 136 of the Constitution of India. The Special Leave Petitions are, accordingly, dismissed.

However, it is observed that the amount so deposited, pursuant to the impugned interim order, shall not be permitted to be withdrawn by the original Claimants till the first appeals are decided and the amount shall be invested in a Fixed Deposit carrying interest cumulatively.

In the facts and circumstances of the case, the High Court is requested to decide the Appeal(s) as early as possible and, preferably, within a period of six months from the date of receipt of the present order.

It is made clear that we have not expressed anything on merits in favour of either parties.
