UPON hearing the counsel the Court made the following  
O R D E R

Sh. Shyam Divan, learned senior counsel appearing for the petitioners, informs us that Petitioner No. 1 is only the fiancée of Petitioner No. 2 and is not involved at all in these offences, but has yet been incarcerated in jail for a period of seven months. On reading the papers, we find that this is *prima facie* correct. We, therefore, enlarge Petitioner No. 1 on ad-interim bail, subject to usual conditions to be imposed by the trial court.
