The Principal Magistrate, Juvenile Justice Board, Sitapur shall send the order declaring the appellant Awadhesh as juvenile."

It is further submitted that in the impugned judgment dated 20.05.2020, no consideration has been bestowed on the issue of juvenility of the petitioner as noted above.
