Heard Mr.Anand Sanjay M.Nuli, learned counsel for the appellant and Mr. V.S.Chopra, learned counsel for respondent No.1.

In the course of hearing, a suggestion was given to the learned counsel for the appellant whether the claim put forth in the claim petition will stand satisfied if the amount of compensation is further enhanced by a sum of Rs.6,00,000/- (Rupees six lakhs). Learned counsel for the appellant accepted the same. Learned counsel for respondent No.1-insurer, however, left it to the discretion of this Court. The amount of compensation is enhanced accordingly.

Having heard learned counsel for the parties, we direct that the insurer shall deposit the enhanced amount before the Small Causes Court at Bangalore within twelve weeks hence.

If the enhanced amount is not deposited within the stipulated time, it shall carry interest @ 9% p.a. from the date of presentation of the application. If, however, it is deposited

within time, no interest shall accrue on the same.

The appeal stands disposed of in the above terms. There shall be no order as to costs.
