Leave granted.

We have heard learned counsel for parties.

We find that the two initial people who were party to the incident, one of them has already got bail being Amit Yadav. Amongst the other people who are alleged to have joined in, four people have got bail while as per information received by learned counsel for the appellants, two of them have not even been arrested possibly because they were not found involved. There are three appellants before us.

Insofar as the stage of trial is concerned, post framing of charges, evidence of prosecution is in progress.

In view of all the aforesaid facts and circumstances, we enlarge the appellants on bail on the terms and conditions to the satisfaction of the trial Court.

Needless to say, that the appellants will fully cooperate with the trial and will not take any unnecessary adjournments and in

case they don't do so, we grant liberty to the trial Court to cancel their bail.

The appeal stands disposed of.
