UPON hearing the counsel the Court made the following
O R D E R

1. Learned counsel for respondent No.2/complainant states that during the pendency of the Special Leave Petition, the dispute with regard to supply of sugar came to be initially settled vide Settlement Agreement dated 07.03.2022, in terms whereof the petitioners, who are Directors of the Shree Sai Krupa Sugar & Allied Industries Limited, were obligated to supply 800 MT sugar to

the respondent/complainant. However, only 761 MT was supplied and in lieu of the balance quantity, a sum of Rs.10,00,000/- (Rupees Ten Lakhs) has now been paid to the respondent/complainant.

2. In view of these subsequent developments, learned counsel for respondent No.2/complainant undertakes that he will withdraw the complaint filed under Section 138 of the Negotiable Instruments Act, 1881.

3. Respondent No.2/complainant shall do the needful within two weeks.

4. The Special Leave Petition stands disposed of as infructuous in the above terms.

5. As a result, the pending interlocutory application also stands disposed of.
