This petition seeks transfer of proceedings in Divorce Petition being Original Suit No.611 of 2018 titled as Ajit Singh vs. Jaspreet Kaur pending before the Family Court of Dhanbad, Jharkhand to the Principal Judge, Family Court, Allahabad, U.P.

Having considered the pleadings and having considered the submissions of the parties, the court is of the opinion that interest of justice requires that the petition should be allowed.

Accordingly the proceedings in Divorce Petition being Original Suit No.611 of 2018 titled as Ajit Singh vs. Jaspreet Kaur pending before the Family Court of Dhanbad, Jharkhand is transferred to the Principal Judge, Family
