C.A. No. 4741/2021

Both respondents have already filed the counter affidavit.

Hence, the matter be processed for listing before the Hon'ble Court, under the rules.

C.A. No. 7638/2022

Certificate of service is awaited from the concerned Tribunal in respect of sole respondent.

Let reminder be issued.

List again on 22.04.2024.

C.A. No. 534/2023

Delay in filing spare copies is condoned.

Registry to issue notice.

List again on 22.04.2024.

C.A. No. 515/2023

Four weeks' time is given to sole respondent to file the counter affidavit. After expiry of four weeks, the matter shall be processed for listing before the Hon'ble Court.

C.A. Nos. 2494 and 3367 and 5642/2023

Despite service of notice on sole respondent there is no appearance on his behalf.
