We have heard the learned counsel appearing for the parties.

This Court, by an order dated 23rd October, 2019, directed payment of compensation of Rs.2,06,75,000/- in toto. The order is silent in relation to the payment of interest on the said amount.

Having regard to the facts and circumstances of the case, we are of the view that it is just and proper to award interest at the rate of six per cent per annum. Hence, we direct payment on interest at the rate of six per cent per annum on Rs.2,06,75,000/- from the date of the claim petition till the date of its deposit.

Application (M.A. No.2064 of 2020) for modification is accordingly disposed of.
