2. As per Office Report service is complete but none has appeared on behalf of the respondent.

3. Having considered the facts and circumstances of this matter and the submissions made by the learned counsel for the petitioner, we deem it appropriate to allow these Transfer Petitions.

4. Accordingly, the Matrimonial Case No. 68 of 2021 pending before the 2nd Principal Judge, Family Court, DJ Division, Sasaram, Bihar and (2) Domestic Violence Case No. 02 of 2022 pending before 45 JM, 1st Class, CJM Division, Sasaram, Bihar be transferred to the Principal Judge, Family Court, Dhanbad, Jharkhand and the Court of the learned Judicial Magistrate First Class, Dhanbad, Jharkhand.

5. Records of the cases should immediately be transferred to the transferee court.

6. The parties may explore the possibility of settlement through Mediation. The transferee court would obtain the desire and wishes of the parties and proceed accordingly in this regard.

7. The parties are at liberty initially to appear through virtual mode. If such request is made, the concerned court may favourably consider the same and thereafter, if need be, the parties can be asked to appear through physical mode.

8. The Transfer Petitions are allowed accordingly.

9. Pending application(s), if any, shall stand disposed of.
