**UPON hearing the counsel the Court made the following
O R D E R**

- 1 During the pendency of these proceedings the Financial Commissioner, Revenue and Disaster Management Department Haryana, Chandigarh has passed an order dated 14 December 2022.
- 2 Counsel appearing on behalf of the State of Haryana states that the order passed by the Financial Commissioner is final and the State is ready and willing to abide by the terms of that order.
- 3 IA No 20206 of 2023 by the petitioner is for the waiver of the interest liability computed at 12% per annum in the order of the Financial Commissioner.
- 4 We are not inclined to waive the direction for the payment of interest. The IA for waiving the liability on account of interest is accordingly rejected.
- 5 In view of the order which has been passed by the Financial Commissioner, Revenue and Disaster Management Department Haryana, Chandigarh on 14 December 2022, the Special Leave Petition shall stand disposed of in terms of that order.
