SLP(Civil) No. 15425/2020

The application (IA No.284022/2024) to bring on record the settlement agreement dated 13.08.2024 is taken on record.

2. Heard Mr. Jay Savla, learned Senior Counsel appearing for the defendant in Summary Suit. Also heard Mr. Deepak Nargolkar, learned Senior Counsel appearing for the petitioner (plaintiff).

3. When this case was last listed on 09.08.2024, the following order was passed:-

"It is the joint submission of the learned counsel for the parties that an out of Court settlement is reached on the financial terms. However, since the money is required to be remitted to a party based in Sweden, the money has to be routed after obtaining permission of the RBI authorities. The appropriate amendment of the settlement clause and formalities are now to be done.

Accordingly, as prayed for, the matter stands deferred by six weeks."

4. Since then, the parties have reached the out of Court settlement on 13.08.2024. Joint submission is therefore made

by the learned counsel for parties that the matter be disposed of in terms of the said settlement agreement dated 13.08.2024.

5. Finding the above prayer to be reasonable, the matter stands disposed of in light of the settlement reached by the parties. The signed agreement dated 13.08.2024 is made part of this Court's order.

6. The concerned counsel has handed over the application in Court, can formally be placed on case records.

7. Pending applications stand closed.
