This writ petition is filed for a direction to allot a seat to the petitioner in M.S. Surgery in ESIC Medical College, Basaidarapur, New Delhi in a vacant seat. Mr. Sanjay Jain, learned Additional Solicitor General took us through the documents filed by the petitioner to submit that the last date for admissions was 14.8.2020. The application submitted by the petitioner was incomplete as the preference for the course was not mentioned in the application. The last date for filling up the seats in the Post Graduate Medical Course was extended by this Court till 30.8.2020. During the stray vacancy counselling, the petitioner submitted another application on 21.8.2020 giving all particulars pertaining to the preference of courses.

Mr. Gaurav Sharma, learned counsel appearing for the

National Medical Commission submitted that an application filed by the State of Tamil Nadu seeking a direction to fill up the vacant seats in Post Graduate Medical Course was dismissed by this Court on 16.9.2020 on the ground that no direction to fill up vacant seats can be given after the last date. We are not in favour of granting any relief to the petitioner as the last date of admissions expired on 30.08.2020.

Writ petition is dismissed. Pending application(s), if any, shall stand disposed of.
