O R D E R

The petitioner/applicant claims to be a practicing lawyer, but acting as a busybody has sought to intervene in person in a matter which has no concern with him. It is quite obvious that the petitioner is acting at the behest of some third parties in lending his name, extremely inappropriate for a counsel. The orders passed by us in the main matter clearly protect the rights of the parties and they have no grievance. It is high time that the Court comes down heavily and discourages such endeavour of litigation which is through filing an application in a decided matter and by separately filing a petition on the same cause by an unconcerned person.

We, thus, dismiss the Miscellaneous Applications and the Special Leave Petition with costs of Rs.25,000/- to be deposited with the Mediation and Conciliation Project Committee within four weeks from today.
