O R D E R

This is a transfer petition at the instance of the petitioner-wife seeking transfer of HMA No. 414 of 2017, titled as Squadron Leader Vikas Bargat vs. Smt. Poonam Chechi Bargat & Anr., pending in the Court of Addl. District Judge, Family Court, Chandigarh, to the Court of Principal Judge, Family Court, Jaipur, Rajasthan.

The petitioner has sought transfer of the case mainly on the ground of financial difficulty and her inability to travel from Jaipur, Rajasthan to Chandigarh, leaving her son and old aged mother (widow), to attend the proceedings of the case filed by the respondent.

Having heard learned counsel for the parties and in view of the hardships which will be faced by the petitioner in contesting the case at Chandigarh, we deem it proper to allow the transfer petition and transfer HMA No.414 of 2017, titled as Squadron Leader Vikas Bargat vs. Smt. Poonam Chechi Bargat & Anr., pending in the Court of Addl. District Judge, Family Court,

Chandigarh, to the Court of Principal Judge, Family Court, Jaipur, Rajasthan, along with all records for its adjudication. Ordered accordingly.

Learned counsel for the respondent submits that the respondent is working as a Squadron Leader in Air Force and has been posted at a strategic place. Accordingly, counsel for the respondent requested that the he may be allowed to participate in the proceedings by way of video conferencing and that the Family Court at Jaipur, Rajasthan be directed to dispose of the matter expeditiously. The respondent is granted liberty to make an application for the same before the Family Court, Jaipur, Rajasthan. We direct the Family Court, Jaipur, Rajasthan that as and when such request is made, the same shall be considered and disposed of in accordance with law as expeditiously as possible.
