ORDER

- 1 Counsel for the petitioner seeks a transfer of the divorce proceedings instituted by the respondent from the Family Court Dwarka, Delhi to the court of competent jurisdiction at Hathras, Uttar Pradesh.
- 2 Mr Vikas Singh Jangra, counsel appearing on behalf of the respondent submits that it has been set out in the counter affidavit that the respondent is ready and willing to pay for the expenses of the petitioner to travel and attend the proceedings at the Family Court at Dwarka on every occasion on which the petitioner is required to remain present.
- 3 The respondent shall pay to the petitioner a quantified amount of Rs 5 thousand for every occasion on which the petitioner is required to remain present before the Family Court at Dwarka. The amount shall be paid at the time of appearance before the Family Court.

4 The Transfer Petition is accordingly disposed in the above terms.
