O R D E R

T.P.(Cr1.) No(s). 333-348/2021

Time is sought on the ground that learned Senior Counsel appearing for the petitioner is busy in another Court.

I find from the orders passed from time to time that only one proceeding (CC No. 147/2022) has been stayed by this Court. While making it clear that the issue of locus of the intervener is required to be decided, I have heard the learned senior counsel for the intervenor. It is pointed out by the learned Senior counsel appearing for the intervener that in the said case (CC No. 147/2002), the evidence has been completely recorded and the final arguments on the side of prosecution are completed. The learned counsel appearing for the petitioner seeks time to take instructions on this aspect.

The order dated 24th September, 2021 passed by the learned 2nd Additional Chief Judicial Magistrate, Nagpur, passed in CC No. 147/2002 records that the case was fixed for final arguments on 28th September, 2021.

In view of this factual position, the order dated 5th October, 2021 needs modification. The order is modified by permitting the

Trial Court to complete the hearing of arguments. However, the judgment shall not be delivered.
