Application for permission to file appeal is granted.

This appeal is filed against an order passed by the National Green Tribunal in an application for recall of the order dated 07.01.2020 by which the appellant was directed to pay an amount of Rs.50,000/- as cost for not filing a Progress Report within the time that was prescribed by an order dated 23.10.2019. The subject matter of the application before the National Green Tribunal pertains to Solid Waste Management by the Municipal Corporation at different stages.

The appellant submits that there is no negligence on his part as the Progress Report was sent to the advocate appearing for the Corporation which was not filed within time. Accepting the submissions made

by the appellant, the cost of Rs.50,000/- imposed on the appellant is waived.

The appeal is accordingly, allowed. Pending applications, if any, shall stand disposed of.
