ORDER

- 1 This transfer petition has been filed by the petitioner-wife for transfer of HMOP No 402 of 2019, titled "*M Ramesh vs M Deepika*" from the Family Court, Tiruchirapalli, Tamil Nadu to the court of Family Court, Nellore, District Nellore, Andhra Pradesh.
- 2 We have heard counsel for the parties.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that HMOP No 402 of 2019, titled "*M Ramesh vs M Deepika*" be transferred from the Family Court, Tiruchirapalli, Tamil Nadu to the court of Family Court, Nellore, District Nellore, Andhra Pradesh.

- 4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.
- 5 Counsel appearing for the contesting parties state that the parties shall explore the possibility of an amicable resolution of the matrimonial dispute by appearing before the Mediation Centre attached to the Family Court, Nellore, District Nellore, Andhra Pradesh on the date to be fixed by the Family Court. The respondent may be permitted to appear at least in the preliminary stage through video conferencing platform.
- 6 Pending applications, if any, stand disposed of.
