1. Leave granted.
2. We have heard the learned counsels for the parties.
3. We have read and considered the order of the High Court.
4. Having considered the matter, we are of the view that in the light of our previous order dated 08.05.2017 passed in Special Leave Petition (Crl.) Nos.3661-3662 of 2017, the appellant ought to be heard by the High Court in the Writ Petition No.12526(W) of 2012 which is presently pending before it. We order accordingly.
5. However, we make it clear that it will not be necessary for the High Court to implead the appellant as a party to the writ petition but he may be heard on all questions of law as may be

open to him to be agitated in the High Court in accordance with our order dated 08.05.2017.

6. The order of the High court is modified to the above extent.

7. The appeal is disposed of in the above terms.
