This Transfer Petition filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of the O.P.H.M.A. No. 1359 of 2019 titled as "Avinash V. Nath vs. Chitra Suresh" pending before the Family Court, Kollam, Kerala to the Family Court, Thane, Maharashtra.

Office Report indicates that Notice issued to the respondent-husband has been served on 09.06.2020 but no one has entered appearance on his behalf so far.
