liabilities of Dewan Housing Finance Corporation Limited, prays that the present application may be allowed as the parties have entered into a one time settlement (OTS).

In view of the statement made, I.A. No. 69431 Of 2022 is allowed.

The petitioner is allowed to withdraw the amount of Rs.75,00,000/- (Rupees seventy five lakhs only) along with the interest accrued, if any.

We clarify that the parties would be bound by the terms and conditions of the settlement. In case of any violation, it will be open to the non-applicants/respondents to proceed in accordance with law.
