O R D E R

Applications for substitution are allowed.

Having heard learned counsel for the parties and having perused the impugned orders, we note that in the peculiar facts and circumstances of the instant case the High Court has arrived at the conclusion to grant the benefit to the private respondents. Limiting it to the relief which is granted to the respondents herein, we see no reason to interfere with the impugned orders.

However, if any fresh claims are made by any other employee who has not claimed so far based on the said order, the same shall not be entertained.

The special leave petitions are, accordingly, disposed of.

In view of the disposal of the petitions, the amount due to the private respondents shall be disbursed within a period of eight weeks.
