**UPON hearing the counsel the Court made the following  
O R D E R**

1. Delay condoned.
2. After arguing for some time, Mr. Raju Ramachandran, learned senior counsel appearing for the petitioners in this batch of special leave petitions, seeks permission to withdraw the special leave petitions. He also seeks liberty to apply for review before the High Court, confined to correction of the arithmetical error in computation of the compensation payable to the affected landowners, as ordered.
3. Permission granted.
4. The special leave petitions are dismissed as withdrawn, with liberty as prayed.
5. In the event the High Court, on review, finds that there is no arithmetical error in computation of compensation and dismisses the review petitions, we reserve the liberty of the petitioners to approach this Court afresh challenging the impugned judgment and order dated 11<sup>th</sup> October, 2023 and such dismissal (of the review petitions) notwithstanding the provisions in Order XLVII Rule 7, Code of Civil Procedure, 1908.
6. Connected applications, if any, stand closed.
