O R D E R

The present petition is for transfer of petition for divorce bearing A Petition No. 209 of 2019 (*Amit Anandlal Pardeshi vs. Sou. Shirisha Amit Pardeshi*) pending before the Family Court, Solapur at Solapur, Maharashtra to the Family Court, Ranga Reddy District, Telangana. The reason for which such transfer is asked for is that the petitioner-wife is at present residing with her parents at Hyderabad, Ranga Reddy District, Telangana and it would not be possible for her to defend the divorce petition brought by her husband in Solapur.

On behalf of the respondent-husband it has been argued by Mr. Satya Kam Sharma, learned counsel that the divorce proceeding has reached an advanced stage and at present the matter is pending for cross-examination of witness(es) of the petitioner.

Considering the fact that the petitioner-wife is staying with her parents at Hyderabad, Ranga Reddy District, in my opinion, interest of justice would be

served in the event the Divorce Petition is transferred to the Family Court, Ranga Reddy District, Telangana. Once the records are transferred the Presiding Judge of the Family court, Ranga Reddy District shall allocate the case to an appropriate Bench and the proceeding after transfer is effected shall commence from the stage at which the case was pending in the Family Court, Solapur at Solapur, Maharashtra.

Let the records be transferred forthwith to the Family Court at Ranga Reddy District, Telangana.

The present Transfer Petition stands allowed in the above terms.
