This petition is filed under Section 25 of the Code of Civil Procedure, 1908, seeking transfer of **O.P.(Div.) No. 1360 of 2019** titled as “**Binu P. Thomas Versus Elizabethu George @ Jomal**” pending before the Family Court, Pathnamthitta, Kerala to the Family Court, Faridabad, Haryana.

Having heard learned counsel for the parties and having considered the facts and circumstances of the case, we deem it fit and proper to allow this transfer petition. Accordingly, **O.P.(Div.)
